Pre-registered voters are now required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered (such as voters registering on Election Day, and voters changing precincts), must also provide proof of residence. The following documents can be used as proof of residency if they contain your name and current address, and are current within 45 days of this Election: Residential lease, utility bill, bank statement, paycheck, government check or other government document, or a property tax statement (current within 45 days of final payment due date). Voters who are unable to provide an approved form of identification (or prove residency if required), may have their identities attested to by another registered voter in the precinct, or have the right to cast a provisional ballot. Attesters must also provide an approved form of identification. For additional information about providing proof of identity and/or residency, you may visit the Secretary of State's website at: https://sos.iowa.gov/voterid, or contact the Clayton County Auditor's Office at (563) 245-1106 or the Delaware County Auditor's Office at (563) 927-4701.

Pre-Election Day voter registration for this election closed on Monday, November 15, 2021 at 5:00 p.m. However, eligible persons have the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Please bring a valid and current photo ID that has an expiration date. If the address on your ID is not current, you will need to prove residency.

The last day to request an absentee ballot **by mail** was Monday, November 15, 2021 at 5:00 p.m. However, **In-person** absentee voting is available at the Clayton County Auditor's Office for Clayton County residents and the Delaware County Auditor's Office for Delaware County residents thru 5:00 p.m. on Monday, November 29, 2021.

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For Delaware County, this test will take place in the Jail Basement located within the Delaware County Courthouse at 301 E Main Street, Manchester, Iowa. The public is invited to attend.
